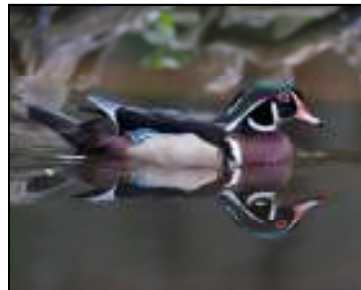
4th ANNUAL PHOTO CONTEST Promoting the beauty of the Winyah rivers

WATERKEEPERS at the front line



As a member of WATERKEEPER® ALLIANCE, we are proud to be a family of nearly 200 Waterkeeper organizations on six continents defending their communities against anyone who threatens their right to clean water. In June, Waterkeepers have two opportunities to gather to discuss and exchange ideas on how to protect those rights. From June 3rd–6th, water protection advocates from across the nation will come together in North Charleston, SC for the National River Rally, hosted by River Network. River Rally serves as a major bridge for a diverse community of organizations, agencies, tribes and businesses working to connect our water, lands, and communities. This is the 12th River Rally but my first. Then from June 22nd-June 26th, Waterkeepers from around the world will be convening at Northwestern University in Chicago for our annual Waterkeeper Conference. A cornerstone of our movement, the annual conference educates, inspires and energizes individual Waterkeeper organizations and strengthens their fight for clean water. SCIENCE CORNER

Litter Contribution to Dissolved Organic Matter in Coastal Blackwater Rivers: Implications of Drinking Water Quality (Part I) - by Alex Chow, Ph.D.

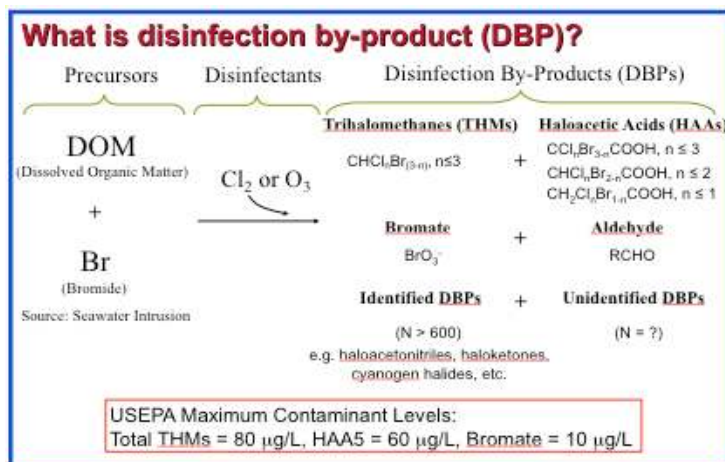


Figure 1. A host of disinfection byproducts can be formed during drinking water disinfection.

Chemical disinfectants are widely used in drinking water treatment to minimize biological contamination and pathogens. However, all chemical disinfectants react with dissolved organic matter (DOM) forming a variety of carcinogenic and mutagenic disinfection byproducts (DBPs) such as chloroform (Figure 1). It is a great health concern in the coastal communities that use blackwater rivers as their drinking water source.

Tea-colored like DOM leached from fresh and decomposed litter materials laying on forested watersheds and wetlands are sources of DOM in coastal blackwater rivers (Figure 2). Chromophore, part of organic molecules responsible for producing color, is related to aromatic carbon content and considered the major reactive moiety with respect to DBP formation during chlorination.

Dr. Alex Chow, faculty at Clemson's Baruch Institute of Coastal Ecology & Forest Science, is currently studying the chemical characteristics of DOM leached from foliar litters to determine potential impacts on drinking water quality. In upcoming issues, Dr. Chow will provide more fundamental knowledge about drinking water disinfection and disinfection byproducts and update his research progress.

Waccamaw River Blue Trail—Come paddle with us!

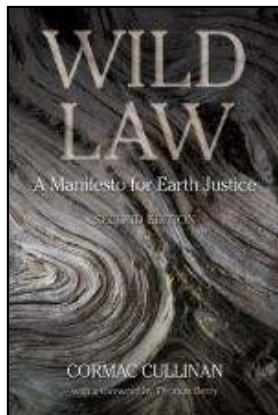
